#### (2) Qualifications

In addition to being registered as electors, candidates must satisfy the other qualifications contained in Sections 75 and 76 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and Section 60 of the Public Elections Act, 2012 (Act No. 4 of 2012), in order to qualify for nomination.
