In exercise of the powers conferred upon it by Section 33 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and pursuant to Section 61 of the Public Elections Act 2012, (Act No. 4 of 2012) the National Electoral Commission hereby makes, the following notices:

(1) Political Party's Lists of endorsed candidates for Parliamentary Bye-Election

Each registered political party intending to present endorsed candidates for the Parliamentary Bye-Election to be held, on **Saturday, 9th Day of July, 2016**, shall submit to the National Electoral Commission a list of endorsed candidates for nomination for the above mentioned bye-election not later than **3:00 p.m. on Monday 6th June, 2016**. Each political party will be required to submit one list with one name of Parliamentary nominee for the said bye-election, together with a statutory declaration in accordance with Section 62 of the Public Elections Act, 2012 (Act No. 4 of 2012).

The following information shall be provided for each candidate:-

1. Name of Candidate
2. Date of Birth
3. Voter Identification Number
4. The Constituency in which he/she will stand for election.

Those candidates not included in any political party list will be registered as Independent Candidates and shall select a symbol from a list of symbols provided by the National Electoral Commission.

Approved candidates will then proceed through the nominations process schedule to take place on **Thursday 9th June, 2016** at the National Electoral Commission District Office: **24 New London, Off Kambia Road, Port Loko Town.**

Guidelines on the nomination of candidates will be issued in due course by the National Electoral Commission.

(2) Qualifications

In addition to being registered as electors, candidates must satisfy the other qualifications contained in Sections 75 and 76 Constitution of Sierra Leone, 1991 (Act No 6 of 1991) and section 60 of the Public Elections Act, 2012 (Act No 4 of 2012) in order to qualify for Nomination.

(3) Nomination Fees

In accordance with Statutory Instrument (No. 13 of 2012), Candidates seeking to stand for nomination for the said **Parliamentary Bye-Election** shall pay a Nomination fee of **Ten Million Leones (Le 10,000,000.00) Per Candidate** to the District Returning Officers in Port Loko District
