PUBLIC NOTICE ON SUBMISSION OF ENDORSED CANDIDATE LISTS BY POLITICAL PARTIES FOR THE PURPOSE OF NOMINATIONS IN THE LOCAL COUNCIL BYE-ELECTION IN WARD 157, CONSTITUENCY 46 IN KOINADUGU DISTRICT

IN EXERCISE of the, powers conferred upon it by Section 33 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and pursuant to Section 61 of the Public Elections Act, 2012 (Act No. 4 of 2012) and Sections 10 of the Local Government Act, 2004 (Act No. 1 of 2004) the National Electoral Commission hereby makes the following notices:

(1) Political Party Lists of endorsed Candidates for Local Council Bye-Election Each registered political party intending to present endorsed candidates for the Local Council Bye-Election in Ward 157 to be held on Saturday 10th Day of December, 2016, shall submit to the National Electoral Commission a list of endorsed candidates for nomination for the above mentioned bye-election not later than 3:00pm on Friday 4th November, 2016. Each Political party will be required to submit one list with one name of Councillor nominee for the said bye-election, together with a statutory declaration in accordance with Section 62 of the Public Elections Act, 2012 (Act No. 4 of 2012)

The following information shall be provided for each candidate :-

- Name of Candidate 1.
- Date of Birth 2.
- Voter Identification Number 3.
- The Ward in which he/she will stand for 4. election.

Those candidates not included in any political party list will be registered as independent Candidates and shall select a symbol from a list of symbols provided by the National Electoral Commission.

Approved candidates will then proceed through the nominations process scheduled to take place on Thursday 9th and Friday 10th November 2016, at the NEC District Office, 158A Main Makeni Road, Kabala Town Koinadugu District.

Guidelines on the nomination of candidates will be issued in due course by the National Electoral Commission.

Qualifications In addition to being registered as electors, candidates must satisfy the other qualifications contained in Section 60 of the Public Elections Act, 2012 (Act No. 4 of 2012) and Section 6 of the Local Government Act, 2004 (Act No. 1 of 2004), in order to qualify for nomination.

Registration Fees In accordance with Statutory Instrument (No. 13 of 2012), candidates seeking to stand for nomination for the said Local Council Bye-Elections shall pay a Nomination Fee of one Million Leone only (Le 1,000,000,00) per candidate to the District Returning Officers at the above mentioned address in the District.
