## NOTIFICATION FOR THE PUBLIC DISCLOSURE OF THE ENVIRONMENTAL, SOCIAL AND HEALTH IMPACT ASSESSMENT OF THE SIERRA RUTILE LTD AREA 1 PROJECT

This notice serves to infrom interested and/or Affected Persons/Parties (I & APs) about the Environment Social and Health Impact Assessment (ESHIA) conducted in relation to Sierra Rutile Limited's (SRL) Area 1 Project (SR Area 1).

SRL's Mining Lease Areas span the Moyamba and Bonthe Districts. The SRL operation in SR Area 1 has an existing Environment License and has undertaken two previous Environmental and Social Impact Assessment, in 2001 and an update in 2012. The primary mining process was dredge (wet) mining. In 2013, SRL, commenced an open cast (dry) mining operation, and a second one was commissioned in 2016. It is anticipated that, over time, dredge mining will cease, and dry mining would be the primary mining method employed.

In accordance with a notification issued to SRL by the Environment Protection Agency of Sierra Leone (EPA-SL), SRL is undertaking an Environment, Social and Health Impact Assessment (ESHIA) and developing and Environmental, Social and Health Management Plan (SEHMP) for their current and proposed dry and wet mining activities, including the proposed expansion areas within SR Area 1. This includes the Gangama and Lanti deposits and other deposits within SRL's current operations in SR Area 1.

In compliance with the laws of Sierra Leone, the project needs to be planned, designed and implemented in a manner that minimizes the potential negative social and Environmental impacts and maximize the benefits. This will be achieved through the ESHIA Process that the Consultanat, SRK Consulting (SRK), an experienced environmental assessment consultancy with vast experience in environmental assessments/ management and related issues, have undertaken. This assessment is now at the stage where the results are required to be presented to interested and affect parties (1&APs) for discussion and finalization. The assessment reports submitted to the EPA-SL on 29th March 2018, are to be presented to the I&APs during public disclosure meeting for discussion at the following locations and dates.

## DECISION A/DEC.2.01/2018 IMPOSING INDIVIDUAL SANCTIONS AIMED AT RESTORING DEMOCRATIC GOVERNANCE AND ENSURING RESPECT FOR THE RULE OF LAW IN GUINEA BISSAU

#### Govt. Notice No. 269

#### THE AUTHORITY OF HEADS OF STATE AND GOVERNMENT

MINDFUL of Articles , 11 and 12 of the Protocol relating to the Mechanism for Conflict Prevention, Management, Resolution, Peacekeeping and Secutity signed in Lome on 10 December 1999;

MINDFUL of the ECOWAS Declaration of Political Principles adopted in Abuja on 6 July 1991;

MINDFUL of the Protocol on Democracy and Good Governance signed in Dakar on 21 December 2001;

MINDFUL of the principles set out in the OAU Solemn Declaration on Security, Stability, Development and Cooperation in Africa adopted in Abuja on 8 and 9 May 2000, and Decision AHG DEC. 142 (XXV) on the framework for OAU's reaction to unconstitutional change of government adopted in Algiers in July 1999;

**CONSIDERING** that the Guinea Bissau authorities have endorsed the Bissau and Conakry Agreements to be implemented to ensure return to contitutional and democratic order in the Republic of Guinea Bissau;

CONSIDERING that despite the continued mediation efforts no significant progress has been made in the implementation of the agreements;

**TAKING DUE ACCOUNT** of the final communique of the extraodinary session of the ECOWAS Authority of Heads of State and Government held in Addis Ababa, Ethiopia, on 27 January 2018, in the margins of the 30th Ordinary Session of the Assembly of Heads of States and Government of the African Union:

**RECALLING that THE ECOWAS** Authority of Heads of State and Government, at its Extraordinary Session held on 27 January 2018, invited the Guinea Bissau parties to implement the Conakry Agreement failling which individual and collective sanctions would be imposed to end the crisis in Guinea Bissau;

**RECALLING** also that the Authority instructed the President of the Commission to apply the sanctions and put in place a committee, comprising Togo, Guinea and the ECOWAS Commission, to monitor the implementation of the sanctions;

NOTING that the Conakry Agreement has not been implemented and hence the need to impose sanctions on defaulters;

**DESIROUS** of creating favourable conditions for the resumption of dialogue among Guinea Bissau stakeholders, as well as for the restoration of democratic governane and respect for the rule of law in Guinea Bissau;

#### DECIDES

### Article 1 Imposition of sanctions

By virtue of this Decision, sanctions are imposed on the following persons:

## Article 2 Sanctions

The sanctions stated hereunder contained in Supplementary Act A/SA.13/02/12 of 17 February 2012 on sanctions against Member States which fail to honour their obligations to ECOWAS and Article 45 of the Protocol on Democracy and Good Governance are imposed on the afore-mentioned persons:

- (a) Suspension from participation in Community activities,
- (b) Travel ban and denial of visas for these persons and their families,
- (c) Freeze of the financial assets of these persons and their families wherever they may be.

#### Article 3 Notification of Sanctions

- The President of the Commission shall notify the Chairperson of the Afrian Union Commission and the African Union Peace and Security Council of the Decision for any appropriate action.
- The President of the Commission shall equally notify Member States, Community Institutions, European Union, International Organisation of the Francophonie, CPLP and United Nations of the Decision and request the support of these organisations in implementation of the sanctions.

Article 4 Review of the list of persons under sanctions

The committee monitoring implementation of the sanctions shall reserve the right to review the list of persons placed under sanctions based on changes in the situation.

#### Article 5 Entry into force and publication

The Decision, which shall enter into force upon signature, shall be published by the Commission in the Official Journal of the Community within thirty days of its signing. It shall equally be published by each Member States in its national Gazette within the same timeframe, following notification by the Commission.
