
**REVOCATION OF PETROLEUM LICENCES IN RESPECT OF
BLOCKS SL-03-17 AND SL 4A-17**

Pursuant to section 115 of the Petroleum (Exploration and Production) Act, 2011 the Director General of the Petroleum Directorate hereby announces the revocation with effect from 1st November 2018 of the Petroleum Licences for Block SL-03-17 granted to European Hydrocarbons Limited on 23rd April 2010, and for Block SL 4A-17 granted to African Petroleum (SL) Limited on 17th September 2012.

The revocation of the Licences is as a result of the breach of the conditions of the Licences, to wit, the work programme under the respective Licences thereby invoking the Drill or Drop provision.

Block SL-03-17: European Hydrocarbons Limited failed under its Third Amendment Agreement dated 1st November 2017 to fulfil the firm-commitment obligation to drill at least one exploration well in the Contract Area on or before the 31st October 2018 before the termination of the Second Extension Period.

Block SL 4A-17: African Petroleum (SL) Limited failed under its First Amendment Agreement dated 1st November 2017 to fulfil the firm-commitment obligation to drill at least one exploration well in the Contract Area on or before the 31st October 2018 before the termination of the Second Extension Period.
