The Sierra Leone Electricity and Water Regulatory Commission, with the support of the Millennium Challenge Corporation under the Threshold Program for Sierra Leone, has been developing regulations aimed at improving access and efficient delivery of electricity and water services.

These regulations are aimed at developing a culture wherein the entities (as listed below) are mandated to improve the quality of supply of water and electricity services. This will essentially improve the culture of compliance for all the related entities engaged in the business of supplying water and Electricity in the Country.

The EWRC will therefore visit various locations in the country to mainly consult with the consuming public and other relevant stakeholders to incorporate their views in the final draft before laying in Parliament. The Public Consultations will be held as follows:

In exercise of the power conferred on it by Section 33 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and pursuant to the Provision of Section 28 of the Chieftaincy Act, 2009 (Act No. 10 of 2009), the National Electoral Commission (NEC) in collaboration with the Ministry of Local Government and Rural Development (MLGRD) makes the following proclamation.

**The period Tuesday 29th January to Saturday 25th May, 2019** is hereby declared as the dates for the Declaration of rights and the conduct of Paramount Chieftaincy Elections in Sierra Leone.

The vacancies occurred as a result of death of the substantive Paramount Chiefs in the respective Chiefdoms.
