THE FIFTH PARLIAMENT OF THE SECOND REPUBLIC OF SIERRA LEONE Short title.  
COMMENCEMENT OF THIRD SESSION

PROCLAMATION, 2020

IN EXERCISE of the powers conferred upon him by subsection (1) of section 84 of the Constitution of Sierra Leone (Act No. 6 of 1991), the President hereby makes the following proclamation—

NOW, THEREFORE, I, Julius Maada Bio, President of the Republic of Sierra Leone, Supreme Head of State, Grand Commander of the Order of the Republic, Commander-in-Chief of the Armed Forces, Fountain Head of Unity, Honour, Freedom and Justice, Do hereby prorogue the Second Session of Parliament with effect from 20th April, 2020 and proclaim the commencement of the Third Session of the Fifth Parliament of the Second Republic of Sierra Leone at Parliament Building, Tower Hill, on Tuesday the 21st April, 2020 at 10 O'Clock in the forenoon.
