TREATMENT OF FUNDS IN THE ABANDONED PROPERTIES ACCOUNT OF COMMERCIAL BANKS HELD AT THE EANK OF SERVER LEONE

WHEREAS section 121 or the laterlang Act. 2019 makes general provisions in relation to abandoned property.
