**JOINT NATIONAL NEGOTIATING BOARD (JNNB) NOTICE OF A  
NEW NATIONAL MINIMUM WAGE**

The Joint National Negotiating Board herein after called the (Joint National Board), mandated under the  
Regulation of Wages and Industrial relations Act No. 18 of 10th December 1971 to fix minimum rates of  
pay, paid public holidays and maximum hours of work for employees below supervisory level has concluded  
discussions and hereby announces a New National Minimum Wage of NLE800 to replace the current minimum  
Wage of NLE 600 a month.

In consonance with section 6 of the Regulation of Wages and Industrial Relations Act No. 18 of 10th December,  
1971 the Sum of NLE 800 is now fixed as the New National Minimum wage for employees below supervisory  
level. The new minimum wage shall come into effect on the 1st April, 2023.

**TERMINATION OF STATE LAND LEASED TO DR. HENRY OBIDIAH WILLIAM FRAZER LYING  
SITUATE AND BEING AT 28 HORSE SHOE ROAD, KISSY DOCKYARD FREETOWN IN  
WESTERN AREA OF THE REPUBLIC OF SIERRA LEONE**

I am directed by the Minister of Lands, Housing and Country Planning to refer to the above subject matter and to inform that you are in Violation of Section 2 Paragraph II, IV&V and Section 3 Sub Section I Paragraph III, IV&V as provided for in the Lease Agreement dated 20th January, 1995 which stipulates as follows:

Contrary to Section 2 Paragraph I: As client of the Ministry, you failed to pay the rent in the manner as prescribed in the agreement.

Contrary to Section 2 Paragraph II: Failed to rehabilitate, refurbish and up keep the entire piece of land as demised by the lessor in the agreement. In the same violation, you did not obtain any planning approval as provided for in the agreement.

Contrary to Section 2 Paragraph IV: Failed to maintain the land and building for the designated use at all times.

Contrary to Section 2 Paragraph V: Failed to maintain or keep up with the hygiene conditions required for human habitation.

Contrary to Section 3 Sub Section I Paragraph III, IV & V: No review was done on the lease agreement, no notice of intention to review same which implied termination of the lease.

Additionally, the Ministry notes with regret that since 2013 you reneged on your obligation in updating your

lease rent payment to Government thereby causing huge financial loss to Government. This in itself is a complete contravention of the lease agreement.

Failure to comply with Section 2 Paragraph 1, II, IV & V of the Lease Agreement for the lease of state land at 28 Horse Shoe Road, Kissy Dockyard Freetown, the offer therein has been revoked forthwith in accordance with the Public Lands Act, Cap. 116 that stipulates thus:

*Whenever any land which has been acquired under the provisions of this Ordinance for a public work is not required for the purpose thereof. Or the said public work has been abandoned, it shall be lawful for the Minister to sell, exchange, lease or in any other manner dispose of such land, and any monies arising from the said sale, exchange, lease or other disposal thereof shall be carried to, and form part of, the general revenue."*

Consequent to the above, the Ministry is now inclined to repossess the said land without further recourse to you.
