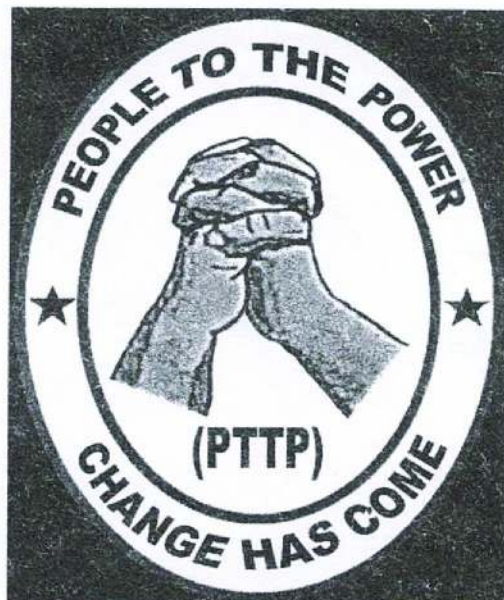

## PREAMBLE

Because of the Economic, Social, Political, Development and related challenges faced by us Sierra Leoneans since our independence in 1961 to date.

More specifically:

Because of the insensitivity of the Political Leadership toward an inclusive governance system and pattern from Ward (Community - Grass Root) Level to Constituency, District Regional and National Levels including but not limited to Gender sensitivity issues especially women's representation and status at all quarters and levels of governance systems and structures.

AND by reason of the repeated challenge towards a Fair and Just Sierra Leone wherein the dignity, respect, and equality of all Sierra Leoneans Citizens are paramount and are treated with the seriousness same deserve.

Because of the lack of Political commitment by the Political Leadership to the tradition of social democracy, based among other things, on prioritizing the benefit of the majority and a shared commitment to the common good at both Local and National Levels without prejudice to Tribal, Regional and Political Party line and or affiliation.

Because of the absence of Material and Legal conditions in practice assuring the Sierra Leonean Populace of their freedom and equality in all spheres parallel with equal participation and opportunities in life, to ensure that our national resources and collective efforts are marshaled to the benefit of society as a whole rather than the individual.

AND because of the worsening and alarming condition of Social injustice inequality, exploitation of natural and human resources manifesting on the repeated circle of poverty among majority of Sierra Leoneans.

We the founding members of People To The Power (PTTP), having deep interest among other interests in Shaping and promoting the Political Will of all Sierra Leoneans, Disseminating information on Political ideas, Social and Economic programs of a national character, supporting candidates for Presidential, Parliamentary and Local Government/Council elections and above all, with our desire to now function as a Political Party in Sierra Leone among other things, we have on the 1st Day of December in the year 2021 agreed to establish the **People To The Power (PTTP) as a Political Party.**

We the founding members of the PTTP Political Party have on the Day of 2022 unanimously consented with the content of this constitution and further agreed that same be registered to the Political Parties Registration Commission (PPRC) being the designated statutory authority for registration pursuant to Section 11 of The Political Parties Act No 3 of 2002 (As Amended).

Upon registration as a Political Party, the operations PTTP shall be tailored to work in conformity with the principle of Unity Freedom and Justice and enhancing sustained democratic principles and practices in Sierra Leone.

Subject to the provision of Act No 6 of 1991; the Sierra Leone 1991 Constitution (As Amended) and or any other existing Law in force in respect of Political Parties in this Republic of Sierra Leone, the provisions herein in this shall take precedence over all other Rules, Regulations, Bye-law(s) and is binding on all members of the P.T.T.P Political Party.



**ARTICLE 1****THE NAME , MOTTO, SYMBOL AND COLOUR OF THE PTTP PARTY****1. NAME**

The Name of the Party shall be the "PEOPLE TO THE POWER" Political Party hereinafter referred to as 'PTTP Party'.

**2. MOTTO**

The Motto of PTTP Party shall be "CHANGE HAS COME"

**3.SYMBOL**

- a) The Symbol of PTTP Party is Two Hands binded together in the middle of a circle with two grey stars ; one on the left and one on the right sides of the circle all of which signify collective and united efforts towards national development.
- b) Organisations, Bodies, Groups, Units established by and under the PTTP Party shall use or display the Party's symbol.

**4.COLOUR**

The colour of PTTP Party shall be GRAY with WHITE background.

**ARTICLE 2****THE AIM AND OBJECTIVES OF THE PTTP PARTY**

THE Vision and Mission of the PTTP Party shall be guided by the following AIMS and OBJECTIVE.

**1. AIM**

The Aim of PTTP party shall be based on collective and united efforts towards a Sierra Leone where citizens are empowered Politically, Socially, Economically, Legally, Educationally thereby contributing constructively towards sustainable national Policies and Development Processes and Programs.

**2. OBJECTIVES**

More specific to our AIM of the PTTP Party are the following Objectives:

- a. To strengthen the capacities of citizens to contest for elected positions in Local Councils, Parliament and the Presidency.
- b. To attain Political Leadership in Sierra Leone through constitutional and related statutory means.
- c. To create conducive Political, Social and Economical conditions for Sierra Leoneans for effective and constructive participation in the Country's Democratic Processes.
- d. To nurture in the mind of Sierra Leoneans the spirit of respect for Human Right, Democratic Principles, Patriotism and Tolerance.
- e. To cultivate the spirit of unity and togetherness in the minds of Sierra Leoneans irrespective of Social-economic and or Political status in society.
- f. To contribute to sustainable governance systems and processes at Local, Regional and National Levels in Sierra Leone.
- g. To nurture in the minds of Sierra Leoneans the spirit of Country-First over and above self, Cultural, Regional and Political Party affiliation.
- h. To promote the implementation of fundamental Human rights as provided for in the Sierra Leone 1991 Constitution, other Human Rights related Laws enacted by the Parliament of Sierra Leone including those Treaties, Conventions to which the Sierra



leone Government is a signatory.

- i. To promote and maintain national unification and integration in Sierra Leone regardless of ethnics, social, economic, religious, cultural, and other differences.
- j. To promote free enterprise system and create a conducive environment for foreign investment in the Republic of Sierra Leone.
- k. To ensure that the resources and opportunities are available for all citizens regardless of sex, class, religion, or ethnic origin.
- l. To promote equal access to education, health, and other social services for Sierra Leoneans.
- m. To establish a government of the Republic of Sierra Leone based on a majority vote of all eligible voters at regular free and fair elections which is more responsive to the needs and aspirations of the citizens.
- n. To enhance effective competitive multi-party democracy in the Republic of Sierra Leone.
- o. To reform the governance system in Sierra Leone with a focus on combating corruption; preventing wastefulness and mismanagement of public-government resources, indiscipline.
- p. To invest in the human and productive capacities for productivity and efficiency in the management of public resources in Ministries, Departments and Agencies(MDA)
- q. To promote and protect the positive customs, values, and traditions Sierra Leone.
- r. To pursue positive policies and programs which ensures economic opportunities for Sierra Leoneans for financial and economic activities
- s. To undertake other strategic activities incidental to the actualisation of PTTP Aims and Objectives aforementioned.

### **ARTICLE 3 PRINCIPLES OF P.T.T.P PARTY**

As a Political Party, PTTP shall operate in Sierra Leone and beyond guided by the following principles.

#### **1) NATIONALISM**

As a political Party, PTTP believes that Political and Administrative leadership and positions ought to be accompanied by or with a high sense of nationalism in the minds of citizens which in no doubt will help achieve sustained efforts towards national development. To this end PTTP Party shall relentlessly work towards ensuring that Sierra Leoneans nurture in mind and work with a high sense of nationalism for the betterment of Sierra Leone.

#### **2) EQUALITY**

As a Political Party we hold on to the very fundamental principles of Human Rights especially the spirit of Equality among others. To this end, PTTP shall work towards ensuring that all qualified citizens shall have equal opportunity to activate and realise the fullness of their respective potentials in society thereby enhancing their active and constructive participation in the governance systems and processes including but not limited to high quality public service and service delivery systems.

#### **3) PROGRESS**

Rooted from the our Motto "CHANGE HAS COME" , PTTP believes in Progress at all spheres and length of development from the least of all communities to a national level development in Sierra Leone. In this regard, PTTP shall be committed towards mobilising resources and support for a much more strong, stable and innovative economy including support to indigenous small, medium and large scale businesses and support to sustainable social and human development initiative such as training and capacity building and strengthening programs for employment.

#### **4) DEMOCRACY**

BY our acronym PTTP interpreted as " POWER TO THE PROPLE" , we believe and hold on to Democratic Principles to the highest esteem because power is given to the people through democratic means and processes. To this end, PTTP will galvanise efforts to capacitate and empower citizens enough to be confident ; at ease , without fear and without any sense of discrimination when aspiring for Political Positions and engaging in the Governance Processes and systems in



Sierra Leone.

#### **ARTICLE 4 REGISTERED OFFICE**

1. The PTTP Political Party shall have its registered headquarter Office in Freetown and with Sub-Offices in all the Provincial Areas in the Republic of Sierra Leone.
2. Branches of the PTTP Party Office shall also be established in friendly countries.
3. The National Executive Council (NEC) shall have the power by this constitution to establish, suspend, close, dissolve any branch office or body as it thinks or deems fit.

#### **ARTICLE 5 MEMBERSHIP OF THE PTTP PARTY**

1. Subject to the provisions in the Sierra Leone 1991 Constitutional (As amended) and other Statutory Provisions, membership to the PTTP Political Party is open to all Sierra Leoneans who are in agreement with the Party's Aim, Objectives Principles and vision in its entirety.
2. Membership in the PTTP Party shall be classified either as Ordinary members, Executive Members, Associate or Organisational Members and Sponsors.
3. By Associate or Organisational membership, PTTP shall accommodate and work with Professional, Trade, Cultural and Social Organisations, Bodies, Unions or Groups among others whose Vision and Mission singularly and or collectively are in conformity with the Aims, Objectives and Principles of the PTTP Party.
4. All registered members shall be issued with a Party membership Card upon payment of their membership fees as determined from time to time by the designated and authorised official of the Party.
5. Any Organisation, Bodies, Unions or Groups etc having an interest to attain membership in or under the PTTP Party shall provide copies of their constitution and any other relevant document so requested by any designated National Regional, District or Ward Level designated body within the Party.
6. Any Individual or Organisational member whose actions, conduct or omissions contravene with the provisions of this constitution of the PTTP Party shall:
  - a. Be subject either to a fine or be suspended as the case may be.
  - b. Be expelled from the Party after three different sets of warning letters have been served on the individual or the organisation.

#### **ARTICLE 6 FUNDING**

The PTTP Party shall be funded by:

1. Registration fees, dues from registered members.
2. Monthly or annual subscriptions by members.
3. Returns from all PTTP Party Fund raising activities.
4. Returns from investments, endowment, dividends etc.
5. Donations by Party members and like-minded persons or organisations, agencies, organisations and institutions.

6. Any other lawful source approves by the Party Executives.

#### **ARTICLE 7**

#### **RIGHTS AND OBLIGATIONS OF PTTP PARTY MEMBERS**

##### **RIGHTS**

1. Every fully paid up member of the party shall have right to fully participate in the party's activities, deliberations, discussions and decisions.
2. Party Members who have fulfilled the stipulated requirements set by the National Executive Council shall have right to vote and be voted for in party meetings, conventions, conferences, contested party positions and also be qualified as delegate in the national level convention of the party.

##### **OBLIGATIONS**

3. All members of the PTTP Party shall promote the Aim, Objective and principles
4. All members shall refrain from any unlawful acts or conducts that are inconsistent with the interest of the PTTP Party.
5. All PTTP Party members shall conform to the Rules and Regulations, directives and decisions of the party and any of the authorised constituent organs.
6. PTTP members shall pay the required fees and levies as may be prescribed by the National Executive Council or any other body so authorised by the NEC.

#### **ARTICLE 8**

#### **THE STRUCTURE AND ORGANISATION OF THE PTTP PARTY**

1. The PTTP Party is a National Political Party and shall be structured and operated on that basis accordingly.
2. **The PTTP Party structure and Organisation (Organ) shall be constituted in six levels ie:**
  - I. COMMUNITY LEVEL
  - II. WARD LEVEL
  - III. CONSTITUENCY LEVEL
  - IV. DISTRICT LEVEL
  - V. REGIONAL LEVEL AND
  - VI. NATIONAL LEVEL
3. **PTTP COMMUNITY LEVEL ORGAN**
  - A. The Community level Organ of the PTTP Party shall constitute of all PTTP registered and up-to date paid up members within the community with a Executive Committee.
  - B. The Executive Committee shall principally constitute of the the following Officers
    1. The Community Chairperson
    2. Vice Chairperson
    3. Secretary
    4. Public Relations Officer
    5. Organizing Secretary
    6. Women's Leader
    7. Young Generation Leader
    8. Disable Leader
    9. Financial Secretary
    10. Publicity Secretary

##### **C. MEETINGS**

Except for urgency and emergency purposes there shall be Quartely Ward Level General meetings



and Monthly Executive meetings for each Wards.

#### **4. PTTP WARD LEVEL ORGAN**

A. The Ward level Organ of the PTTP Party shall constitute of all PTTT registered and up-to date paid up memners within the Ward with a Executive Committee.

B. The Executive Committee shall principally constitute of the the following Officers

1. The Ward Chairperson
2. Vice Chairperson
3. Secretary
4. Public Relations Officer
5. Organizing Secretary
6. Women's Leader
7. Young Generation Leader
8. Disable Leader
9. Financial Secretary
10. Publicity Secretary

#### **D. MEETINGS**

Except for urgency and emergency purposes there shall be Quartely General meetings and Monthly Executive meetings.

#### **5. PTTP CONSTITUENCY LEVEL ORGAN**

A. There shall be a Constituency level Organ of the PTTP Party which shall consist of all registered and up-to date paid up memners within the Constituency with a Executive Committee.

B. The Executive Committee shall principally constitute of the the following Officers

1. The Constituency Chairperson
2. Vice Chairperson
3. Secretary
4. Public Relations Officer
5. Organizing Secretary
6. Women's Leader
7. Young Generation Leader
8. Disable Leader
9. Financial Secretary and
10. Publicity Secretary all at constituency level.

#### **D. MEETINGS**

Except for urgency and emergency purposes there shall be Quartely General meetings and Monthly Executive meetings.

#### **6. PTTP DISTRICT LEVEL ORGAN**

A. The District level Organ of the PTTP Party shall constitute of all PTTT registered and up-to date paid up memners within the District with an Executive Committee.

B. The Executive Committee shall principally constitute of the the following Officers

1. The Ward Chairperson
2. Vice Chairperson
3. Secretary
4. Public Relations Officer
5. Organizing Secretary
6. Women's Leader
7. Young Generation Leader
8. Disable Leader
9. Financial Secretary
10. Publicity Secretary

#### **D. MEETINGS**

Except for urgency and emergency purposes there shall be Quartely General meetings and Monthly



Executive meetings.

**7. PTPP REGIONAL/PROVINCIAL LEVEL ORGAN**

- A. There shall be a Regional/Provincial level Organ of the PTPP Party which shall consist of all registered and up-to date paid up memners within the Region/Province with a Executive Committee.
- B. The Executive Committee shall principally constitute of the the following Officers
1. The Regional Chairperson
  2. Deputy Regional Chairperson
  3. Secretary
  4. Public Relations Officer
  5. Organizing Secretary
  6. Women's Leader
  7. Young Generation Leader
  8. Disable Leader
  9. Financial Secretary
  10. Publicity Secretary.

**D. MEETINGS**

Except for urgency and emergency purposes there shall be Quartely General meetings and Monthly Executive meetings.

**8. PTPP NATIONAL LEVEL ORGAN**

- A. There shall be a National level Organ of the PTPP Party which shall consist of all registered and up-to date paid up memners.
- B. The National Level Organ shall constitute of the following bodies:
- A. NATIONAL EXECUTIVE COUNCIL (NEC).
  - B. NATIONAL ADVISORY COMMITTEE (NAC)
  - C. NATIONAL POLICY COMMITTEE ( NPOC)
  - D. NATIONAL PARLIAMANTARY COMMITTEE ( NPAC)
  - E. NATIONAL SECRETARIAT ( NACSEC)

**C. NATIONAL OFFICERS**

1. The PTTT party shall consist of the following National Officers:

- a. National Chairman and Leader
- b. Deputy National Chairman and Leader
- c. National Secretary General
- d. Deputy National Secretary-General
- e. National Treasurer
- f. National Financial Secretary
- g. Public Relations Officer and Deputy
- h. National Organizing Secretary
- i. Assistance National Organizing Secretary
- j. Diaspora Affairs Officer and Deputy
- k. National Women's Leader and Deputy
- l. National Leader on Disability Issues and Deputy
- m. National Youth Leader and Deputy
- n. National Publicity Secretary
- o. National Internal Auditor
- p. Three (3) Legal Officers
- q. Four (4) Trustees, one per region
- r. Imam
- s. Chaplain

**D. COMPOSITION**

- a. The NATIONAL EXECUTIVE COUNCIL (NEC) shall consist of
  - I. All the National Officers of the PTTP Party with the National Chairman and Leader as Chairperson.
  - II. Elected members of Parliament and
  - III. All Regional Chairpersons of the PTTP Party.
- b. The NATIONAL ADVISORY COMMITTEE (NAC) shall consist of:
  - I. National Chairman and Leader as Chairperson
  - II. The Deputy National Chairman and Leader
  - III. Ten Senior professional members in the PTTP Party of at least Ten years standing in their respective profession or career.
  - IV. Four members of parliament each representing one region in Sierra Leone.
  - V. All the Deputy Regional Chairpersons of the PTTP Party
- c. The NATIONAL POLICY COMMITTEE (NPOC) shall consist of:
  - I. The National Chairman and Leader as Chairperson.
  - II. At least Five PTTP Party members with expertise in Policy and Policy related issues including One Lawyer.
  - III. All the Regional Chairpersons of the PTTP Party
- d. The **NATIONAL PARLIAMANTARY COMMITTEE (NPAC)** shall consist of:
  - I. The National Chairman and Leader as Chairperson.
  - II. All elected Parliamentarians at a given Parliamentary Term
  - III. Two Former Parliamentarians
  - IV. One Lawyer different from that in the NPOC
  - V. All Regional Chairpersons of the PTTP Party
- e. The **NATIONAL SECRETARIAT (NASEC)** shall consist of the following:
  - I. The Secretary General as the Head
  - II. Assistant Secretary General
  - III. National Publicity Secretary & Assistant
  - IV. National Organising Secretary & Assistant
  - V. National Treasurer
  - VI. Leaders of Youth, Woman & Disable Persons.
  - VII. Heads of Foreign Affairs, Education, Welfare, Research and Information Departments.
  - VIII. Save for the Leaders and Heads of Departments aforementioned, all positions in the secretariat



shall be elected positions for three years per term and not exceeding two terms.

#### **D. MEETINGS**

- a. **NATIONAL EXECUTIVE COUNCIL (NEC).**  
Except for emergency and urgency, NEC shall meet on a quarterly basis.
- b. **NATIONAL ADVISORY COMMITTEE (NAC)**  
Subject to an emergency issue or issues NAC shall meet every quarter
- c. **NATIONAL POLICY COMMITTEE (NPOC)**  
NPOC shall meet at any given time issues of National Policies emerge or re-emerge.
- d. **NATIONAL PARLIAMANTARY COMMITTEE (NPAC)**  
Except otherwise, NPAC shall meet every quarter.
- e. **NATIONAL SECRETARIAT (NASEC)**  
The National Secretariat shall meet every month.

### **ARTICLE 9**

#### **THE POWERS, FUNCTIONS-RESPONSIBILITIES OF PARTY ORGANS AND OFFICERS.**

##### **1. ORGANS**

###### **A. NATIONAL EXECUTIVE COUNCIL (NEC).**

1. NEC shall be the highest decision making body in the PTTP Party.
2. NEC is the body responsible to coordinate all national level related activities and direct and supervise regional level activities and programs of the PTTP Party.
3. NEC shall have the power to appoint the Trustees herein.

###### **B. NATIONAL ADVISORY COMMITTEE (NAC)**

As a body constituting of Senior professional members in the PTTP Party from diverse careers, NAC shall be the supreme advisory body on all strategic National Issues at both Party and Governmental levels.

###### **C. NATIONAL POLICY COMMITTEE (NPOC)**

NPOC shall be responsible for providing the necessary technical advise and support to the constituent bodies in the PTTP Party on Government Policies and related issues.

###### **D. NATIONAL PARLIAMANTARY COMMITTEE (NPAC)**

NPAC shall be the highest body responsibility to deliberate on Bills and any other Policy proposal tabled in the House of Parliament and take the necessary constitutional and legal actions to that effect.

###### **E. NATIONAL SECRETARIAT (NASEC)**

NASEC shall be in charge of running the Daily Administrative affairs of the PTTP Party supervised by the National Chairman and Leader.

##### **2. NATIONAL OFFICERS**

###### **A. NATIONAL CHAIRMAN AND LEADER**

- 1) The National Chairman and Leader shall be the Political and Administrative head of the party.
- 2) The National Chairman and Leader shall champion issues relating to National Policies and Regional and International affairs and Relations.
- 3) The National Chairman and Leader shall be the Presidential Candidate for the Presidential

Elections in Siarra Leone subject to any statutory limitation.

- 4) The National Chairman and Leader shall have power to convey, lead and chair all National Level meetings of the PTTP Party except same is delegated on to the Deputy National Chairman and Leader or any other senior National Officer.
- 5) For any lawful reason or reasons the office of the National Chairman and Leader becomes vacant including death, mental or physical disability the Deputy National Chairman and Leader shall complete the ongoing term as Acting National Chairman and Leader with full Powers until the completion of the said term of office.

**B. DEPUTY NATIONAL CHAIRMAN AND LEADER**

The National Chairman and Leader shall have the Deputy National Chairman and Leader as the principal assistant.

**C. NATIONAL SECRETARY GENERAL & DEPUTY**

The National Secretary-General shall:

- 1) Take the lead in the running of the Day to day Administrative and strategic national affairs of the PTTP Party.
- 3) Coordinate and manage all the correspondences relating to the Party
- 4) Summon meetings and take meeting minutes and records.
- 5) Manage the information Systems of the PTTP Party
- 6) Supervise all other officials with Administrative and related functions of the Party from National through Local Levels.
- 7) Be assisted by the Deputy National Secretary-General
- 8) Be supervised by the National Chairman and Leader.

**E. NATIONAL TREASURER**

The National Treasurer shall:

- 1) Be the custodian of all the Funds and finances of the PTTP Party at National Level.
- 2) Expend such funds directly and through designated officials on the approval of the National Chairman and Leader Finance and General-Purpose Committee.
- 3) Report on the expended funds and finances to the National Executive Committee.
- 4) Supervise the National Treasury on the financial issues of the Party

**F. NATIONAL FINANCIAL SECRETARY**

The National Financial Secretary Shall:

- 1) Advise on all financial matters affecting the party
- 2) Keep proper records of all financial transactions of the party.
- 3) Report on the expended finances to the National Treasury

**G. THE NATIONAL PUBLIC RELATIONS OFFICER AND DEPUTY**

The National Public Relation Officer shall:

- 1) Be the lead Spokes Person for the Party.
- 2) Educate the public on the philosophy, programs, and activities of the party
- 3) Liaise with the Mass Media on party line and national interest.



- 4) Assisted by the Deputy National Public Relation Officer

#### **H. NATIONAL ORGANIZING SECRETARY & ASSISTANT.**

The National Organizing Secretary shall:

- 1) Be responsible for organizing and coordinating party activities
- 2) Be the principal liaison officer between the various arms of the party.
- 3) Be the principal contact person for the registration and membership into the PTTP party within the country.
- 4) Be assisted by the Assistant National Organizing Secretary

#### **J. DIASPORA AFFAIRS OFFICER AND DEPUTY**

The Diaspora Affairs Officer shall be the lead person in Siarra Leone responsible for cordinating between Party members in the Diaspora including their intereste, concarns and Party related affairs. Assisted by the Deputy.

#### **K. NATIONAL WOMEN'S LEADER AND DEPUTY**

The National Women's Leader of the shall :

- 1) Champion all the national level Programs, activities and affairs of the womens wing in the PTTP Party.
- 2) Be the lead national focal person for women in the PTTP party.
- 3) Cordinate with heads of all subordinate womens groups in the PTTP party
- 4) Be assisted by the Deputy National Womens Leader in her functions.

#### **L. NATIONAL LEADER ON DISABILITY ISSUES AND DEPUTY**

The National Leader on Disability Issues shall :

- 1) Champion all the national level Programs, activities and affairs of the Disable Persons in the PTTP Party.
- 2) Be the lead national focal person for Disable Persons in the PTTP party.
- 3) Cordinate with heads of all subordinate Disable groups in the PTTP party
- 4) Be assisted by the Deputy National Leader on Disability Issues.

#### **M. NATIONAL YOUTH LEADER AND DEPUTY**

The National Youth Leader shall:

- 1) Champion all the national level Programs, activities and Youth affairs in the PTTP Party.
- 2) Be the lead national focal person for Youth in the PTTP party.
- 3) Cordinate with heads of all subordinate Youth groups in the PTTP party
- 4) Be assisted by the Deputy National Youth Leader .

#### **N. NATIONAL PUBLICITY SECRETARY**

The Publicity Secretary shall be in charge of Publicity and related activities in the PTTP Party.

#### **O. NATIONAL INTERNAL AUDITOR**

The Internal Internal Auditor of the PTTP Party Shall:

- 1) Audit all financial records in respect of the PTTP party.
- 2) Prepare annual audited report for the national and branch accounts to the National Executive Committee.
- 3) Advise and profer recomendations on efficient and proper Financial Management issues

in the Party.

**P. LEGAL OFFICERS**

The Legal Adviser(s) shall:

- 1) The principal Advisers in the PTP Party.
- 2) Represent the Party in Legal Actions and legal matters.
- 3) Educate the party membership on Constitutional and any Legal Issue as the need arises.

**Q. TRUSTEES**

The Trustees in the PTP Party shall:

- 1) Be in charge of handling and managing the assets of the PTP Party.
- 2) Champion conflict management and resolution issues within in the Party.

**R. IMAM/CHAPLAIN**

The Imam and Chaplain shall be in charge of the Religious and Spiritual component of the PTP Party.

**3. REGIONAL, DISTRICT, CONSTITUENCY, WARD & COMMUNITY LEVEL EXECUTIVE OFFICERS.**

The functions, powers and responsibilities of the Regional, District, Constituency Ward and Community level executive Officers shall be as provide above but in their respective levels of executive leadership positions.

**ARTICLE 10  
PTP PARTY ELECTIONS & CONVENTIONS**

**ELECTIONS**

**I. COMMUNITY LEVEL**

- a. Community Level Elections for excutive members shall be held every three years.
- b. An elected executive member shall have the option to contest and be re-elected for a second term.

**II. WARD LEVEL**

- a. Ward Level Elections for excutive members shall be held every three years.
- b. An elected executive member shall have the option to contest and be re-elected for a second term.

**III. CONSTITUENCY LEVEL**

- a. Constituency Level Elections for excutive members shall be held every three years.
- b. An elected executive member shall have the option to contest and be re-elected for a second term.

**IV. DISTRICT LEVEL**

- a. District Level Elections for excutive members shall be held every three years.
- b. An elected executive member shall have the option to contest and be re-elected for a second term.

**CONVENTIONS**

- a. Conventions for the PTP party are held for electing Regional and National Level Executive



**Officers.**

- b. Except for the positions of Legal Officers, Trustees, Imam and Chaplain all other executive positions shall be elected positions.
- c. Conventions shall be held every four years.
- d. Elected and Appointed Executive officers at both Regional and National Levels shall not be re-elected or re-appointed in the same office for more than two terms.
- e. Candidates nominated for the Presidential Elections in Sierra Leone shall contest for the Flag Bearer Position and the candidate with majority votes shall be the Flag Bearer contesting for the Presidency of Sierra Leone for and on behalf of the party.
- f. A candidate shall not contest for the Office of the President of the Republic of Sierra Leone for more than two consecutive times.

**ARTICLE 11****INTERIM PROVISION**

In the interim period, PTPP shall be governed and guided by the following guidelines between its registration and 18 Months after the next Local Council, Parliamentary and Presidential elections.

1. There shall be an Interim National Assembly of Trustees (INAT) constituting principally of the PTPP Founding members.
2. The Interim National Assembly of Trustees (INAT) shall be responsible for the overall governance, management and Administration of the party.
3. INAT shall also take decisions on important and strategic issues including but not limited to the choice of Executive members at every level of the party.
4. INAT shall on a majority consent select or appoint a candidate to contest as a Flag Bearer for the upcoming Presidential elections.

**ARTICLE 12****AMENDMENT**

1. This constitution is subject to an amendment by a two-third majority votes in a SPECIAL NATIONAL DELEGATE CONFERENCE (SNDC) with a composition of Five representatives each District, Five representatives from Western Area and the National Chairman and Leader, The Deputy Chair and Leader, the National Secretary General and the Legal Advisers to the Party.
2. Notification of an amendment to this constitution shall be made at least 90 days before the amendment.
